Introduction and Course Overview

To drive a public passenger bus or coach with 13 or more seats in New South Wales, you must hold a Bus Driver Authority issued by Transport for NSW. To be eligible, you are required to successfully complete an approved bus driver training course. The information below outlines the course content and steps to help you on your path to becoming a qualified bus driver in NSW.

Entry Requirements

Applications to obtain a NSW Bus Driver Authority (BDA) are made online through Service NSW, with eligible applicants having to submit the following:

 A commercial Medical Assessment (completed no more than 6 months prior).

Note: Wait at least 72 hours after your medical assessment before submitting your driver authority application.

 A National Police check issued no more than 3 months prior to this application.

Note: Your Police check must include all current and former names.

- Evidence you have successfully completed the required bus driver training course.
- ✓ A copy of your Driver Licence front and back (scanned as a PDF).

Note: Applicants must have a valid email address

Bus Driver Authority applicants must demonstrate they have the necessary knowledge and competence to conduct on the relevant bus service. The approved online or face-to-face bus driver training course delivered by Into Training NSW is focused on:
